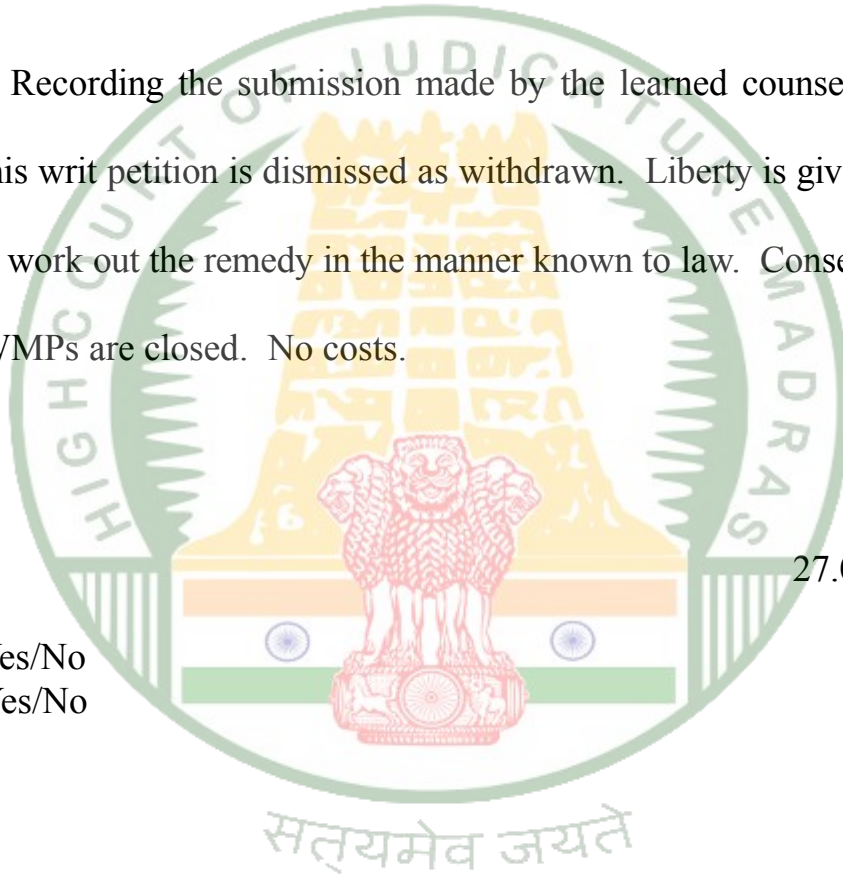
## **ORDER**

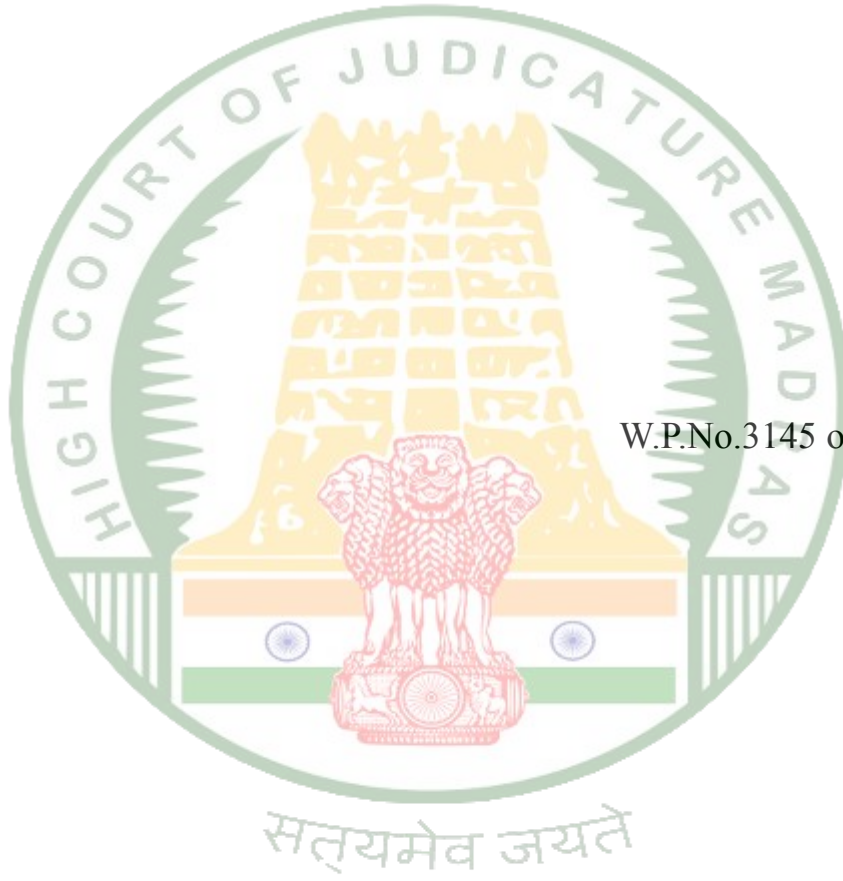
