The present petition have been filed for relaxation of the said condition.

3. The learned Additional Public Prosecutor submitted that the condition imposed in CRL.O.P.No.16062 of 2020 dated 12.10.2020, on the petitioners, have been complied with regularly.

4. In view of the above, the condition imposed on the petitioners in CRL.O.P.No.16062 of 2020 dated 12.10.2020, is modified to the effect that the petitioners are directed to report before the respondent police once in a month i.e., on the first working day of every month at 10.30 a.m., until further orders.
