Prayer : - Writ Petition filed under Article 226 of the Constitution of India praying for a Writ of Certiorari, praying to call for the records of the 1st respondent viz the Revenue Divisional Officer and Land Acquisition Officer, South Chennai Revenue Division, Guindy, Chennai - 600 032, in respect of the impugned Form A (See Rule 3) a show notice dated 01.11.2018 issued under Section (2) of the Section 3 of the Tamil Nadu Acquisition of Land for Industrial Purposes Act, 1977 (Tamil Nadu Act, 10 of 1999) for the land specified and situated in Mylapore Part - I Village, Mylapore Taluk, Chennai District for Corridor - 4-5 Alwarpet Metro Station more fully described in the impugned show cause notice as Block No.34, Survey No.1650/7 description shown as Ryotwari/Quit Rent measuring to an extent of 391 sq.mts belonging to the petitioners herein and quash the same unsustainable in law.
