4. Considering the facts and circumstances of the case, the condition already imposed on the petitioner in Crl.O.P.No.19082 of 2020 dated 11.12.2020, is relaxed and the petitioner is directed to appear before the respondent police once in a week at 10.30 a.m. until further orders.

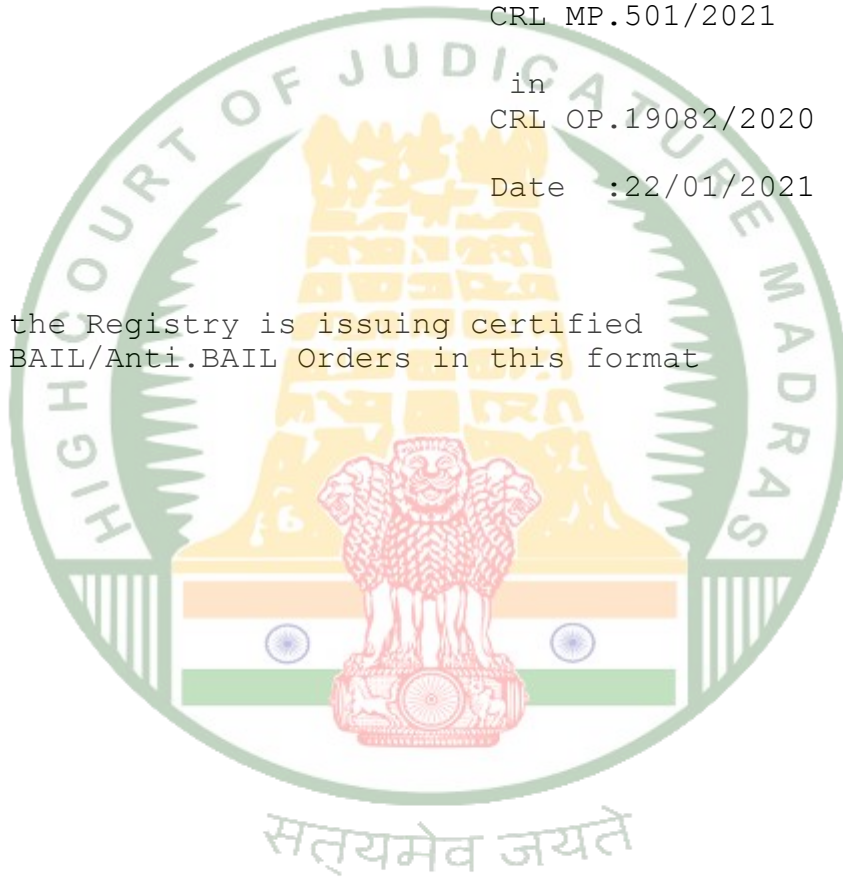
