2.The learned Government Advocate appearing on behalf of the Respondents 1 and 2 submitted the copy of the letter addressed to the Special Government Pleader by the Executive Officer of the Temple stating that the temple properties were already handed over to the temple authorities and the possession has already been taken over by the Executive Officer and further it is stated that the actions are to be initiated to recover the arrears of rent and appropriate petition is filed before the District Court, Cuddalore in E.P.No.161 of 2017.

3.This being the factum established, no further adjudication is required in respect of the grounds raised in the writ petitions and accordingly the writ petitions stand closed. However, there shall be no order as to costs.
