PRAYER: Civil Miscellaneous Appeal filed under Section 173 of Motor Vehicles Act, 1988 against the award and Decree dated 29/04/2008 made in M.C.O.P No.2591 of 2004 on the file of the II Judge, Small Causes Court, (Motor Accidents Claims Tribunal), Chennai.

DECREE: This Civil Miscellaneous Appeal coming on for hearing on this day, upon perusing the grounds of Appeal, the award of the Tribunal below and the material papers in this case and upon hearing the arguments of M/s.K.A.Ravindran, Advocate for the Appellant and of M/s.A.Arunkumar for the 2nd Respondent and steps not having taken to serve notice to the first respondent, this Court while allowing the Civil Miscellaneous Appeal in part by modifying the award of the Tribunal, doth order and decree as follows;

i) that the Compensation awarded in the Judgment and Decree of the Motor Accidents Claims Tribunal/II Judge, Small Causes Court, Chennai made in MCOP No.2591 of 2004 dated 29.04.2008 be and hereby enhanced from a sum of Rs.21,500/- (Rupees Twenty One Thousand and Five Hundred only) to a sum of Rs.36,500/- (Rupees Thirty Six Thousand and Five Hundred only) including interest;

ii)that the second respondent/Insurance Company herein be and hereby is directed to deposit the award amount as determined above, less the amount if any already deposited, within a period of eight weeks from the date of receipt of a copy of this Order;

iii)that on such deposit being made, the share of the Minor Claimant shall be deposited by the Tribunal in any fixed Deposit Scheme in any one of the Nationalised Bank and it shall be renewed periodically until he attains majority and the accrued intrerest shall be withdrawn by his father once in three months;

iv)that there be no costs in this Civil Miscellaneous Appeal;
