3. The learned Additional Public Prosecutor submitted that the condition imposed in CRL.O.P.No.12174 of 2020 dated 29.10.2020, on the petitioner, has been complied with regularly.

4. In view of the above, the condition imposed on the petitioner in CRL.O.P.No.12174 of 2020 dated 29.10.2020, is modified

to the effect that the petitioner is directed to report before the respondent police once in a month i.e., on the first working day of every month at 10.30 a.m., until further orders.
