This Court, while granting bail to the petitioner, imposed a condition that the petitioner shall report before the respondent police daily at 10.30 a.m. in Crl.M.P.No.6807 of 2020 in Crl.O.P.No.14491 of 2020 dated 09.11.2020 until further orders. The present petition has been filed for relaxation of the said condition.

3. The learned Additional Public Prosecutor submitted that the condition imposed in Crl.M.P.No.6807 of 2020 has been complied with regularly from 18.11.2020 to till date.

4. In view of the above, the condition imposed on the petitioner in Crl.M.P.No.6807 of 2020 in Crl.O.P.No.14491 of 2020 dated 09.11.2020, is modified to the effect that the petitioner is directed to report before the respondent police once in a week i.e., on every Monday at 10.30 a.m., until further orders.
