ORDER

4.In view of the above, no further direction is required to be given except that the second respondent/DRO is directed to issue notice to all the parties who are likely to be affected by his decision, provide them a fair and effective hearing and to dispose of the matter through a speaking order within a period of twelve (12) weeks (after the conclusion of the General Elections to the Legislative Assembly - 2021) from 12.05.2021.

5.The Writ Petition is disposed of accordingly. No costs.
