3. The learned counsel for the petitioner, on instructions, submitted that the petitioner is prepared to pay a reasonable amount



as donation to any charitable institution to be identified by this court.

3. Considering the facts and circumstances of the case, this petition is ordered and two weeks' time is granted from the date on which the order copy made ready to comply with the earlier order of this court on condition that the petitioners shall pay a sum of Rs.5,000/- (Rupees Five Thousand Only) as donation either in cash or demand draft or NEFT in favour of 'St. Joseph's Social Service Centre, No.4/92-62, Magazine Road, St.Thomas Mount, Chennai-60016, Indian Overseas Bank, A/C.No. 158101000003277, IFSC Code. No. IOBA0001581. In the event of non compliance of this order, the petition for anticipatory bail shall stand automatically dismissed.

4. The Registry is directed to post the matter on 22.02.2021 along with Crl.M.P.No.6874 of 2020 in Crl.O.P.No.11449 of 2020 and Crl.M.P.No.6875 of 2020 in Crl.O.P.No.12051 of 2020.
