No. 361 / 1B1A for an extent of 0.23 acres out of total extent of 1.41.57 Hectares of lands situated in Pernambut, Pernambut Taluk within a stipulated time as fixed by this Honourable Court (in WP.No.1405/2021)

Order : This petition coming on for orders upon perusing the petition and the affidavit filed in support thereof and upon hearing the arguments of MR.K.A.RAVINDRAN Advocate for the petitioner and of MR.E.BALAMURUGAN Special Government Pleader on behalf of the 1 & 2 Respondents the court made the following order:-
