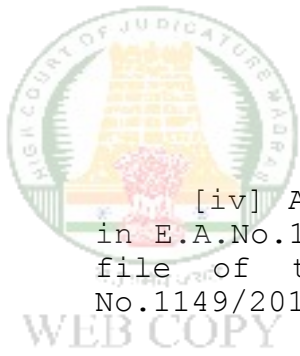

2. This Court by its order dated 17.02.2021 directed the learned I Additional District Judge, Erode to dispose of EP Nos.4 to 8 of 2005, within a period of six months from the date of receipt of a copy of order dated 17.02.2021 passed in CMA Nos.1146 to 1150 of 2016.

The learned I Additional District Judge, Erode has addressed a letter to the Registry on 29.06.2021, informing the Registry that the original Execution Petition records have not been received back from the High Court to enable the learned I Additional District Judge to comply with the directions, within the stipulated time.
