4.In view of the above, no further direction is required to be given except that the third respondent is directed to issue notice to all the parties who are likely to be affected by his decision, provide them a fair and effective hearing and to dispose of the matter through a speaking order within a period of twelve (12) weeks after the conclusion of the General Elections to the Legislative Assembly - 2021.

5.The Writ Petition is disposed of accordingly. No costs.

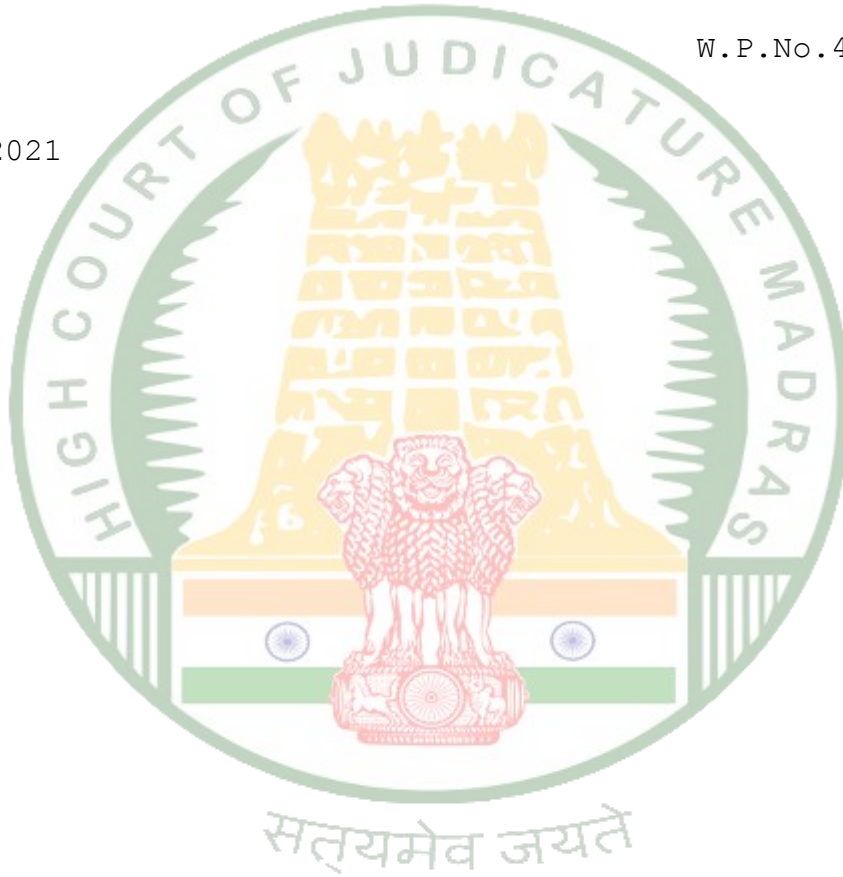
