2011 before the Hon'ble Court for withdrawal immediately.

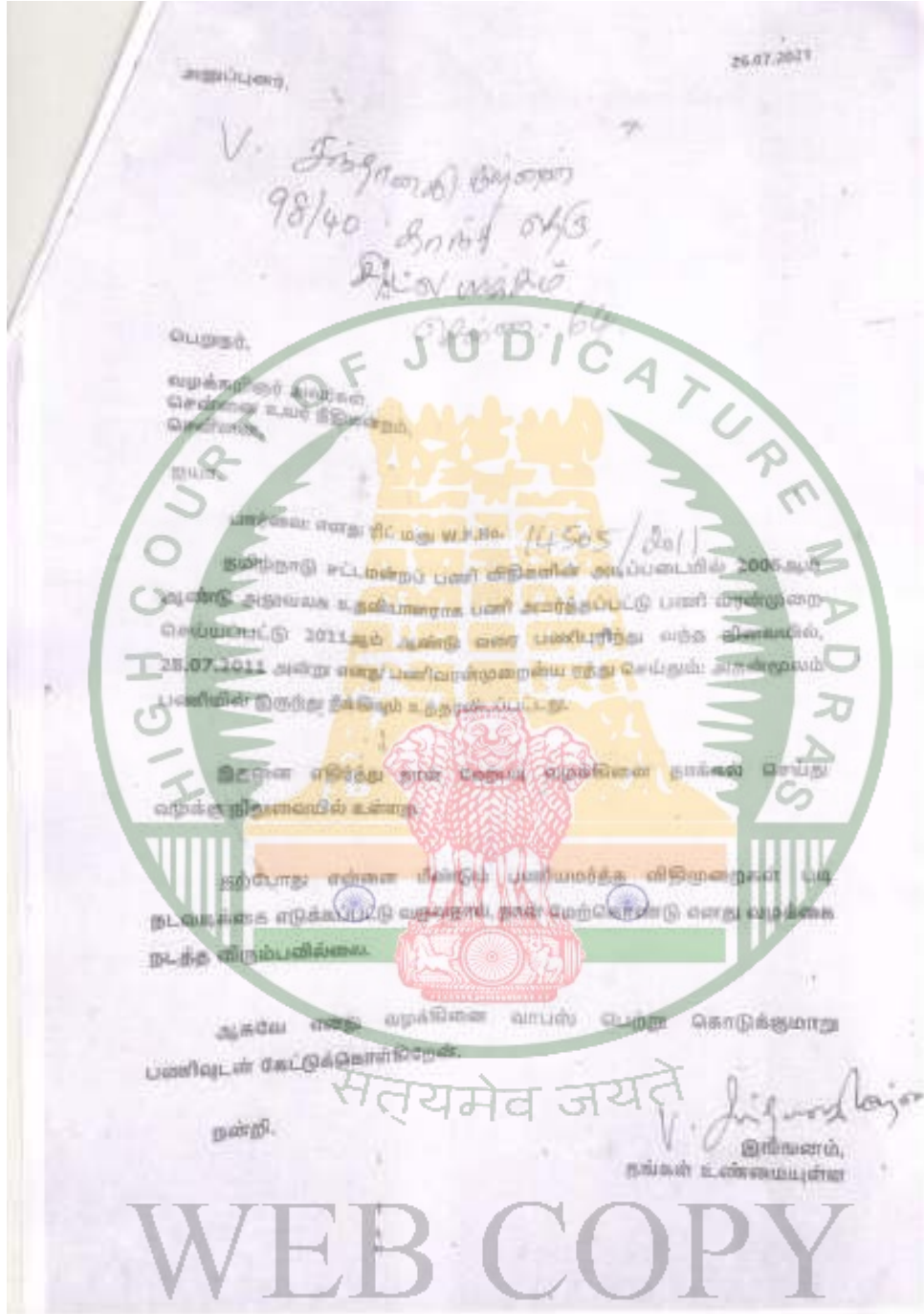

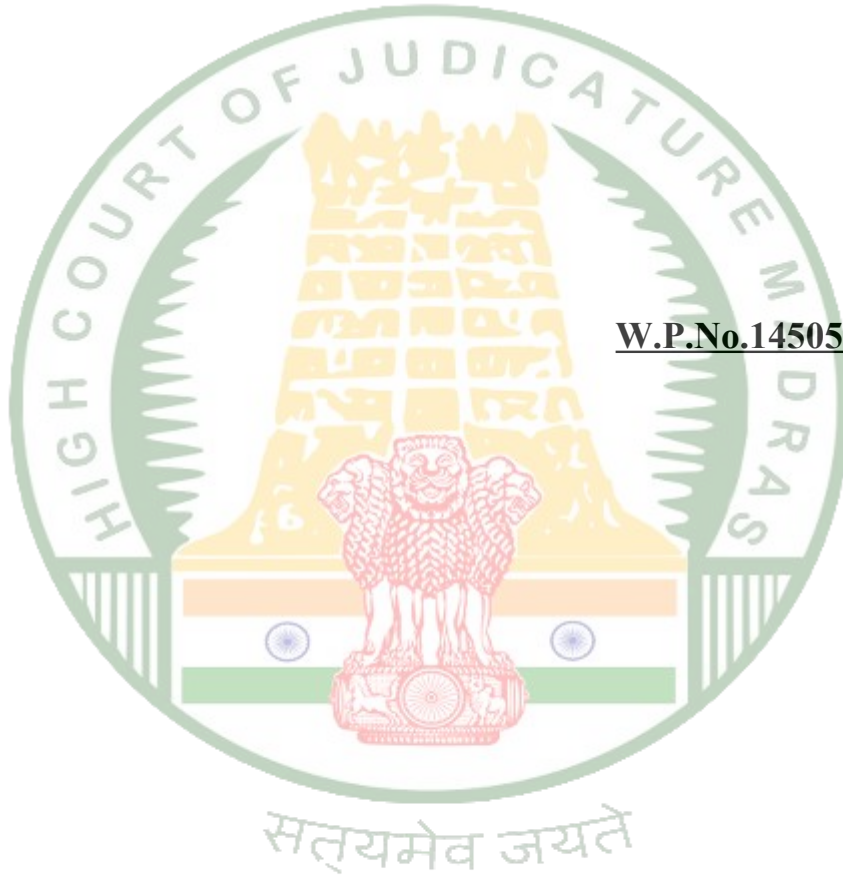
