Prayer in both appeals: Writ Appeals filed under Clause 15 of the Letters Patent against the order dated 06.02.2012 in W.P. Nos.12955 & 25316 of 2010 of his Lordship Mr.Justice B.Rajendran.

Prayer in W.P.12955 of 2010:

Writ petition filed under Article 226 of the Constitution of India praying to issue a writ of Certiorarified Mandamus or any other writ or order or direction in the nature of writ of Certiorarified Mandamus calling for the records of the 1st Respondent comprised in order dated 21.05.2010 in Na.Ka.No.501/2010-A, quash the same arbitrary, illegal, unconstitutional and consequently forbear the respondents from in any manner disturbing the peaceful possession of the property comprised in survey No.602/2, R.S.No.389/5, Thudiyalur Village, Thudiyalur Town Panchayat, Coimbatore by the petitioner trust for the purpose of running school for mentally retarded.

Prayer in W.P.25316 of 2010:

Writ petition filed under Article 226 of the Constitution of India Praying to issue a writ of Mandamus of any other writ or order or direction in the nature of writ of Mandamus, directing the 2nd respondent to forthwith consider and grant supply of electricity service connection to the petitioner school for mentally retarded children being conducted at survey No.602/2, R.S.No.389/5, Muthuswamy Gounder Street, Thudiyalur Town Panchayat, Coimbatore.
