This writ petition has been filed seeking for police protection in order to conduct the consecration ceremony of the temple.

2.When the matter came up for hearing on 29.01.2021, this Court passed the following order:

"1.This writ petition has been filed seeking for police protection in order to conduct the consecration ceremony of Agni Veeranan Alathiyur Amman Temple, Mullukurichi Village, Sendurai Taluk, Ariyalur District.

2. According to the petitioner, the fifth respondent is creating a problem and if a peace meeting is conducted by the first or second respondent, some understanding can be arrived at and the festival can be conducted.

3.The second respondent is directed to call the parties immediately and conduct the peace meeting and ensure that the consecration ceremony is undertaken in a peaceful manner.

4..Post this case under the caption "for reporting compliance" on 02.02.2021."

3.The learned Additional Public Prosecutor on instructions submitted that pursuant to the orders passed by this Court the Tahsildar, Ariyalur District, held a peace committee meeting between the parties and the festival was over yesterday.

4.Recording the submissions of the learned Additional Public Prosecutor, this Criminal Original Petition is closed.

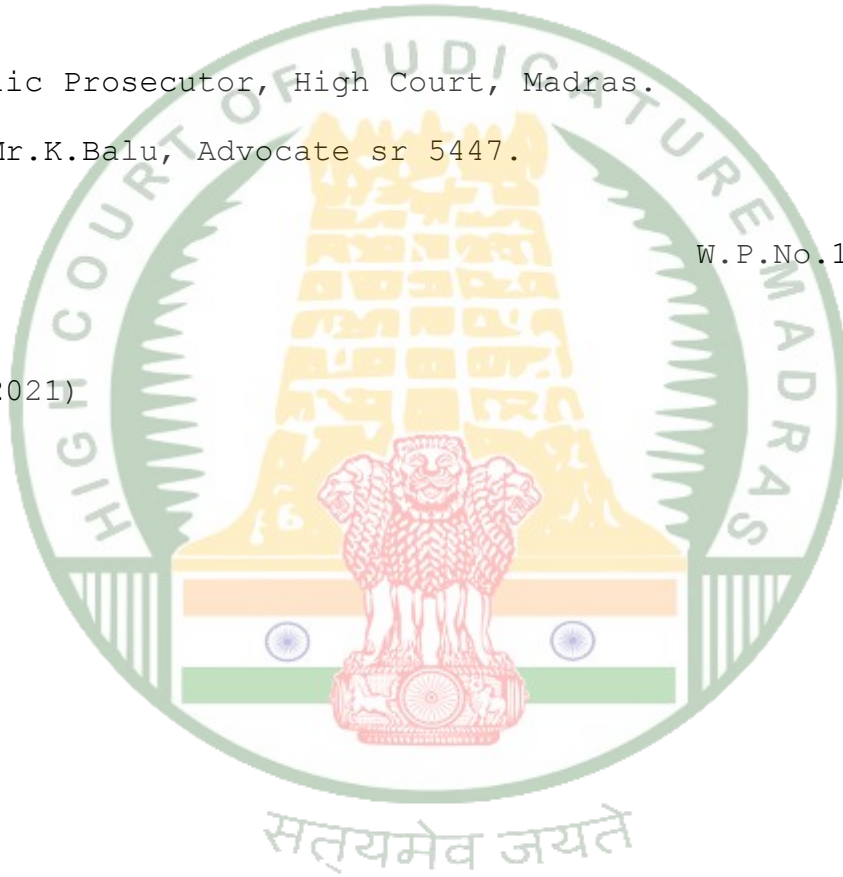
