ORDER

The writ petitioner complains about the alleged encroachment by respondents 8 to 12 on lands comprised in specific survey numbers of Nachapuram Village, Chetpet Taluk, Tiruvannamalai District.

2. It is asserted by the writ petitioner that in spite of issuing a representation of 11.11.2020, no action has been taken by the official respondents.

3. Without examining the merits or tenability of the representation of the petitioner, respondents 4 and 5 are directed to consider the representation dated 11.11.2020 and dispose of the same by a speaking order, after providing a reasonable opportunity to all affected parties, within a period of eight weeks from the date of receipt of a copy of this order.

4. W.P.No.4861 of 2021 is disposed of on the above terms. There will be no order as to costs. Consequently, W.M.P.No.5472 of 2021 is closed.
