Order : This petition coming on this day for hearing upon perusing the petition and the affidavit filed in support thereof and upon hearing the arguments of MR.K.SELVARAJ, Advocate for the petitioner and of MR.P.GUNARAJ, ADVOCATE on behalf of the Respondents the court made the following order:-

The case of the petitioner is that all the Authorities have granted permission to the petitioner for put up a shop at Survey No.273, Putheri, Jamen Pallavaram, Pallavaram Taluk, Chengalpattu District. He is also running an Aavin Parlour for the past six months in the said place. All of a sudden, the respondent / Electricity Board has disconnected the service connection without affording an opportunity and without issuing any notice and without valid reasons.

2. In view of the above, there shall be an interim direction, directing the respondent to restore the Electricity Service Connection No. 246-004-4193 to the petitioner's shop until further orders.

Post this matter after four weeks.
