Appeal preferred under Section 260A of the Income Tax Act, 1961, against the order of the Income Tax Appellate Tribunal, Madras, "B" Bench, Chennai dated 17.07.2008 in I.T(SS). A.No.31/Mds/2007 block period 22.01.2003 and this appeal preferred against the Commissioner of Income Tax (Appeals) II, Chennai 34 order dated 30.11.2006 made in CIT(A)/CHE/199/2004-2005 for the assessment year Block period from 01.04.1996 to 22.01.2003 and against the Deputy Commissioner of Income Tax (I/C) Central Circle 11(3) Chennai 34 order dated 31.01.2005 made in PA/GIR No. AAPPK2443N/26749K for the assessment year relevant to Block period from 1996-1997 to 2001-2002 from 01.04.2002 to 22.01.2003.

JUDGMENT
(Judgment was delivered by M.DURAI SWAMY, J.)

We have heard Mr.T.R.Senthil Kumar, learned Senior Standing Counsel for the appellant/Revenue and Mr.N.V.Balaji, learned counsel for the respondent/assessee.

2.The appeal, filed by the Revenue under Section 260A of the Income Tax Act, 1961 (for short, the Act) is directed against the order dated 17.07.2008 made in I.T(SS).A.No.31/Mds/2007 on the file of the Income Tax Appellate Tribunal, Chennai, "B" Bench (for brevity, the Tribunal) for the block period 22.01.2003.

3.The appeal was admitted on 10.11.2009 on the following substantial questions of law:

"1)Whether on the facts and in the circumstances of the case, the Income Tax Appellate Tribunal was right in law in deleting the addition of Rs.48,00,000/- towards unexplained cash credit even though the assessee has not furnished any details of sources of finance for making investments in Kerala Roadways Private Limited in the form of unsecured loans?

2)Whether on the facts and in the circumstances of the case, the Income Tax Appellate Tribunal was right in law in deleting the addition of Rs.92,94,190/- made on account of unexplained investment in cost of construction even though the assessee could not furnish evidence in support of his claim of investment in the construction is valid"

3)Whether on the facts and in the circumstances of the case, the Income Tax Appellate Tribunal was right in remit the matter to the file of Commissioner of Income Tax (Appeals) with a direction that he should give the basis for working out the admissible relief in respect of the unexplained jewellery to the tune of Rs.6,45,477/- even though the assessing officer made additions to the tune of Rs.15,76,026/- after considering the facts and circumstances and evidence of the case of the assessee?"

4.The learned Senior Standing Counsel for the appellant submits that the above appeal is not pursued by the Revenue on account of the Low Tax Effect in terms of Circular No.17/2019 dated 08.08.2019 issued by the Central Board of Direct Taxes. By the said Circular, the monetary limit for filing or pursuing an appeal before the High Court has been increased to Rs.1 crore. It is further submitted that the tax effect in these cases are less than the threshold limit.

5.In the light of the said submissions, the above Tax Case Appeal is dismissed as withdrawn on account of the Low Tax Effect. The substantial question of law framed is left open. In the event the tax effect in this case is above the threshold limit fixed in the said Circular, liberty is granted to the Revenue to make a mention to this Court to restore the appeal to be heard and decided on merits. No costs.
