To issue, Writ, Order direction more in the nature of Writ of Declaration declaring that the entire examination and the results published for the post of Computer Instructor Grade I published in Notification No 9/19 dated 1.3.2019 by the 3rd Respondent as illegal and arbitrary on the ground of being vitiated by non transparency and mal practice and consequently direct the 3rd Respondent board to conduct a fresh examination for the post of computer Instructor Grade I in a transparent manner by giving an equal opportunity to all the candidates.

To issue a Writ of Certiorarified Mandamus to Call for the records pertaining to the Impugned final Selection List for the



Certificate Vertification dated 28.11.2019 for the direct Recruitment of Computer Instructors Grade I (Post Graduate Cadre) based on notification dated on 01.03.2019 as online computer Bsed Examinatin on the file of the Respondent No. 1 and quash the same as illegal and further direct the Respondent No. 1 to and quash the same as illegal and further direct the Respondent No. 1 to conduct Re examination for all the candidates who appeared the examination conducted by the Respondent No. 1 on 23.06.2019 and 27.06.2019 and passing any further or other orders.
