3. This Court has earlier granted bail to the petitioner on the condition that he report before the respondent police daily. It is alleged that when the petitioner appeared before the respondent police they harassed him. Therefore he seeks modification of the condition as stated above.

4. Considering the facts and circumstances of the case, this petition is ordered and the petitioner is directed to report before

the learned V Metropolitan Magistrate instead of the respondent police on all working days until further orders.
