5.Since the enquiry is already fixed, no further direction is required to be made except that the second respondent is directed to issue notice to all the parties who are likely to be affected by his decision and after providing the parties a fair and effective hearing, to dispose of the representation dated 05.12.2020 of the petitioner through a speaking order within a period of eight(8) weeks from the date of service of order copy, subject to such time that may be lost in responsibilities connected with the ensuing General Election of the Tamil Nadu State Legislative Assembly, 2021.
