The learned Counsel for the petitioner would submit that the petitioner is working as Inspector of Police at Vellore District and that he is undergoing treatment for his leg pain and thereby, he finds it difficult to travel to Thiruvannamalai, everyday to comply with the condition. Hence, he seeks for modification

3. Heard the learned Additional Public Prosecutor appearing for the respondent police.

4. Considering the facts and submissions of the learned Counsels, the condition 6(b) imposed on the petitioner in Crl.O.P.No.19292 of 2020 by order dated 09.12.2020, is modified to the effect that the petitioner shall report before the respondent on the first working day of every month at 10.30 a.m. until further orders.

5. This petition is ordered accordingly.
