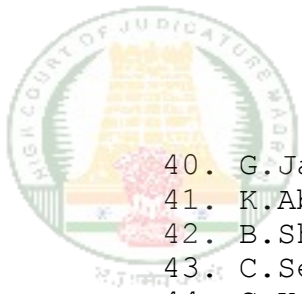

The case of the petitioners is that they are landless poorer daily wage coolies and they have constructed huts and staying in the lands comprised in Survey No. 442 situated at Mogappair Village, Ambattur Taluk, Tiruvallur District for several years. They are claiming patta as per the various Government orders. They sent a representation to the respondents on 09.05.2012, thereby requested to issue patta in their favour.

3. The learned Government Advocate appearing for the respondents submitted that the petitioners sought for patta to an extent of 0.74 acres. Whereas, they are residing at Rani Ammaiyyar Street, Periyar Nagar, Vyasarpadi, Chennai. Therefore, their request cannot be considered.

4. It is seen from the typed set of papers that the petitioners sent representation on 09.05.2012 to the respondents. Due to paucity of several years, the said representation cannot be considered now by the respondents, since it cannot be ascertained as to whether the said representation is available with the records of the respondents or not. However, the petitioners are at liberty to file a fresh representation to the authorities concerned and on receipt of the same, the authorities concerned are directed to consider the same and pass orders on merits and in accordance with law.

5. In view of the above direction, this Writ Petition is disposed of. No costs.
