4. In view of the submission made by the learned Addl. Public

Prosecutor, the respondent Police is directed to complete the enquiry, within a period of four weeks from the date of receipt of a copy of this order and if any prima facie case is made out against the petitioner, the respondent police shall register the First Information Report or close the petition enquiry. Till then, the respondent police is directed not to arrest the petitioner.
