2. The learned counsel appearing for the petitioner submitted that the petitioner is a poor man and he is not in a position to mobilise the said amount to comply with the conditions imposed by this Court.

3. Considering the facts and circumstances of the case, this petition is ordered and the petitioner is exempted from paying Rs.15,000/-. However other conditions remain. Two weeks time is granted to the petitioner to comply with the other conditions imposed by this Court, from the date on which the order copy made ready. Failing which,

the petition for anticipatory bail shall stand automatically dismissed.
