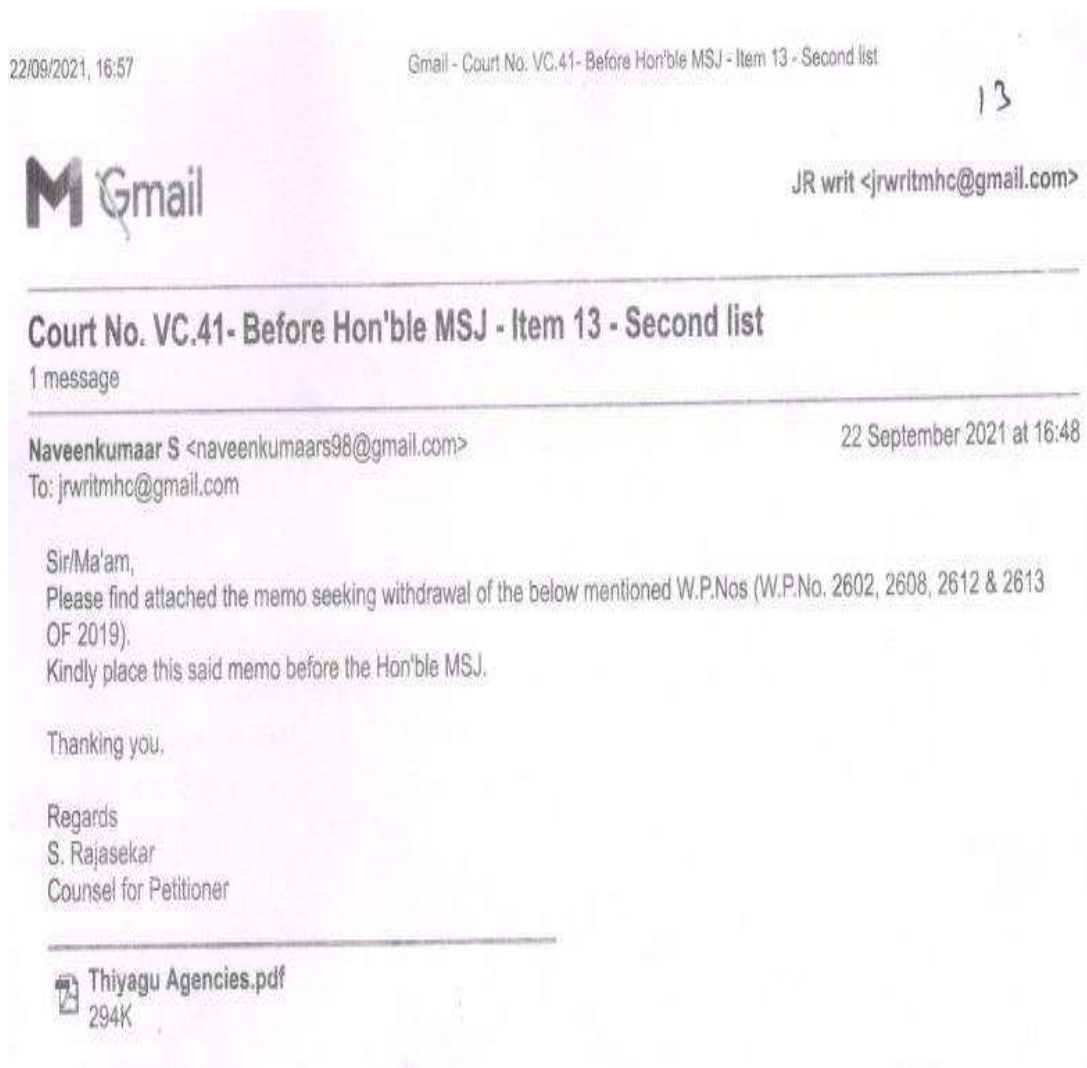
Mr.S.Rajasekar, learned counsel for writ petitioner in all the four captioned writ petitions is before this virtual Court.
