The relief sought for in the present Writ Petition is to direct the respondents 1 to 3 to consider the representation dated 19.11.2014 and to appoint an enquiry commission to look into the irregularities of the Administration of the Executive Committee of the Volley Ball Federation of India over the period from 14.07.2013 to 31.11.2014

2. The Writ Petition was filed in the year 2014 almost 6 ½ years lapsed. During the pendency of the Writ Petition, elections were conducted and the elected office bearers are now administering the association.
