PETITION FOR ANTICIPATORY BAIL Under Sec. 438 Cr.P.C.

ORDER : The Court Made the following order :-

The petitioners, who apprehend arrest at the hands of the respondent police for the alleged offence under Sections 294(b), 324, 406, 498-A and 506(ii) of IPC in Crime No. Not Known of 2021, seek anticipatory bail.

2. Heard the learned counsel for the petitioners and the learned Additional Public Prosecutor appearing for the respondent.

3. When the matter was taken up for hearing, the learned Additional Public Prosecutor appearing for the respondent Police submitted that petition enquiry is pending against the petitioners.

4. In view of the submission made by the learned Additional Public Prosecutor, the respondent police is directed to complete the enquiry, within a period of four weeks from the date of receipt of a copy of this order and if any prima facie case is made out against the petitioner, the respondent police shall register a First

Information Report or otherwise close the petition enquiry. Till then, the respondent police is directed not to arrest the petitioners.

5. This criminal original petition stands closed accordingly.
