ORDER

2.Mr.M.Manigopi, learned Government Advocate takes notice for the respondent and made a statement on instructions that an enquiry on the petitioner's representation dated 11.11.2020 is scheduled to take place on 26.02.2021 at 03.00 p.m. at the office of the respondent/Tahsildar.

4.In view of the above, no further direction is required to be given except that the respondent is directed to issue notice to all the parties who are likely to be affected by his decision, provide them a fair and effective hearing and to dispose of the matter through a speaking order within a period of eight (8) weeks from the date of receipt of a copy of this order, subject to the period, if any lost for the responsibilities associated with the conduct of the General Elections, 2021.

5.The Writ Petition is disposed of accordingly. No costs. Consequently, the connected miscellaneous petition is closed.
