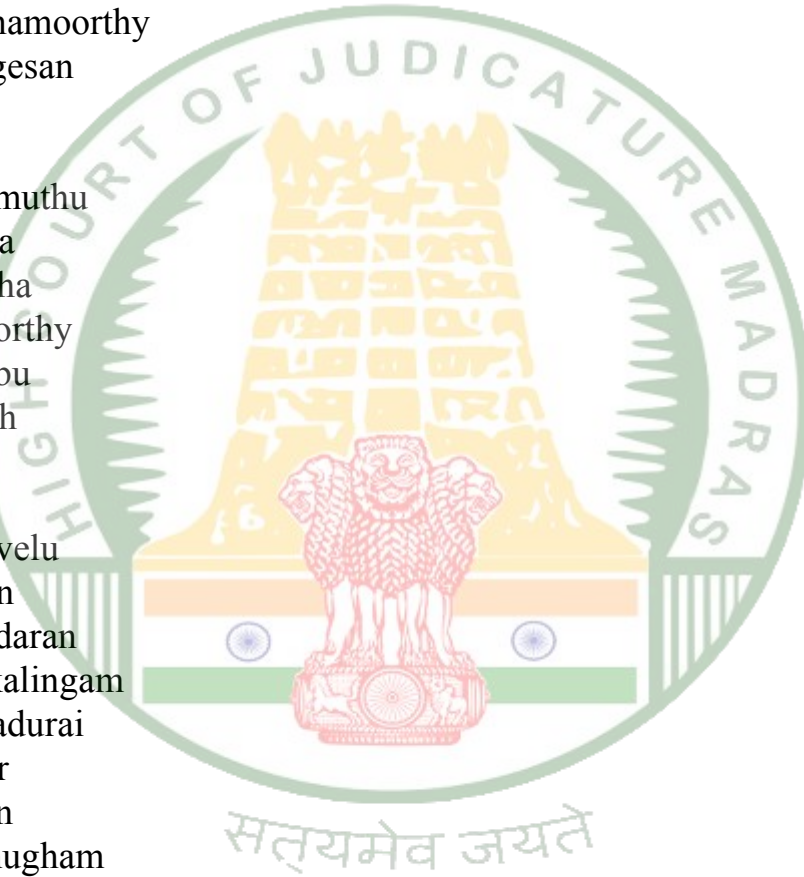

ORDER

2. Today, when the matter was taken up for consideration, the learned counsel for the petitioner, on instructions, submitted that the petitioners have already been evicted and provided with alternative accommodation, hence the relief sought for herein has become infructuous and therefore, nothing survives for adjudication in this writ petition.

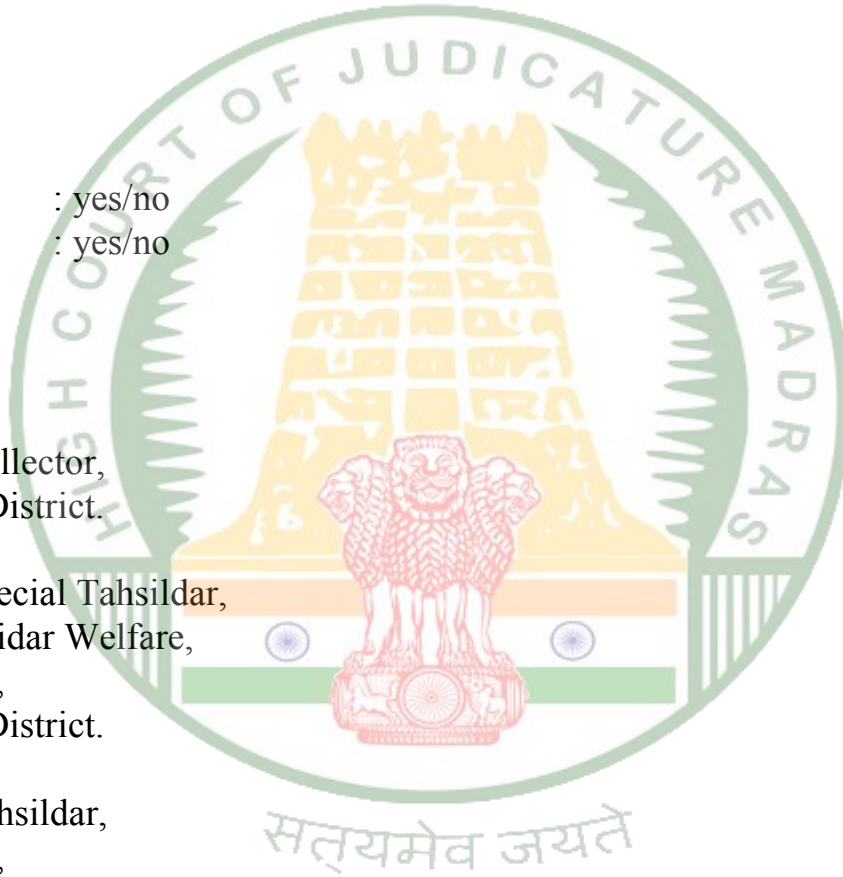

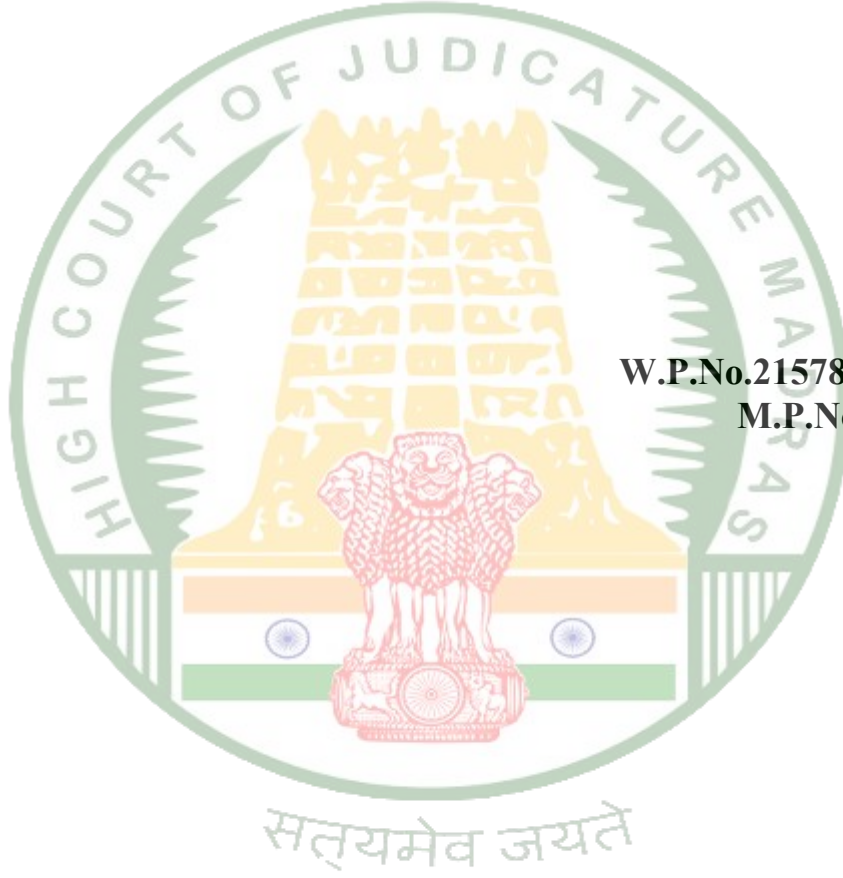
