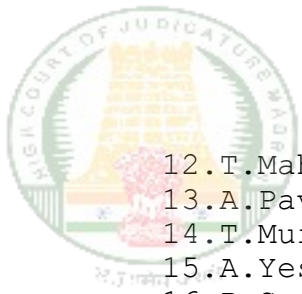

PRAYER: Writ Petition filed under Article 226 of the Constitution of India praying for the issuance of Writ of Certiorarified Mandamus, calling for the records pertaining to the order passed by the 3rd respondent in proceedings



No.Corp/P&A/NEE/2682-2008 dt. 8.1.09 quash the same in so far as giving redesignation as Store Keeper Grade-A/Senior Store Keeper Grade-II and Grade-I and Junior Material controller to the respondents 5 to 12 and consequently direct the respondents 1 to 4 to give seniority to the Stores staff above the 41 sportsmen in the respective grades, with scale of pay and all consequential benefits, on par with the 41 sportsmen from the date on which they were given redesignation as assured and agreed by the respondents 1 to 4, award costs.
