"1. The Appellant herein has preferred the present Appeal under Section 260A of the Income Tax Act, 1961 (the 'Act') challenging the order dated 19.11.2019 passed by the Income Tax Appellate Tribunal ('ITAT'), 'B' Bench, Chennai in ITA No.47/CHNY/2018 for the Assessment Year 2013-14 ("AY").

2. The Appellant herein most humbly submits that as per the 'Vivad Se Vishwas' Scheme and Act, 2020, the appellant herein has preferred to opt for the above mentioned scheme as stipulated vide the notification No.CG-DL-E-17032020-218716 dated 17.03.2020 and through the same act the appellant herein has settled all of his tax dues and thus the appellant herein prefers to withdraw the appeal".
