2. Heard the learned counsel appearing for the petitioners and the learned Additional Public Prosecutor appearing for the respondent Police.

3. Today, when the matter was taken up for hearing, the learned Additional Public Prosecutor appearing for the respondent Police submitted that petition enquiry is pending against the petitioners in C.S.R. No.21 of 2021 before the respondent police.

4. In view of the submission made by the learned Addl. Till then, the respondent police is directed not to arrest the petitioners.
