The matter in issue pertains to challenge to the impugned order, in and by which, the petitioner has sought to be evicted.

The learned counsel appearing for the petitioner, on instructions, would submit that in the light of fact that the impugned notice has been given effect to and he has also been evicted, nothing remains for further adjudication in this Writ Petition. However, the petitioner has also submitted a representation dated 25.01.2021, praying for alternative accommodation and it may be directed to be considered and give a disposal .

3. In the light of the said development, the Writ Petition is dismissed as infructuous and however, the petitioner is granted liberty to pursue other remedies available to him under law, if it is permissible. No costs. Consequently connected miscellaneous petition is closed.
