Prayer:- Writ Petition filed under Article 226 of the Constitution of India, 1950, praying to issue a Writ of Certiorarified Mandamus, praying to call for the records connected with the Proceedings of the First Respondent in Na. Ka. No. 216/2009 dated 06.07.2009 and quash the same insofar as it has not allowed the scale of pay of the pump operator, viz., Rs. 950-20-1150-25-1500 in the Ordinary Grade (V Pay Commission) to the Petitioner as ordered in G.O. Ms. 588 dated 01.08.1992 and further direct the First Respondent to implement the proceedings in Na. Ka. No. 932/95 dated 20.10.1995 and Na. Ka. 11/96 dated 20.02.1996 both passed by the First Respondent from 01.06.1988 with monetary effect from 01.04.1992 and other consequential benefits of the Fifth and Sixth Pay Commission pay etc.
