counsel for the respondents 3 & 4.

Ms.D.Sathya, learned counsel for the respondents 3 & 4 on instructions would submit that peace committee meeting was convened by the second respondent and in view of the said meeting, the temple festival was conducted on 11.03.2021 and he would also submit that there is no bar for the petitioner and others from worshipping the deity at Sri Mega Sakthi Mariamman Temple situated in Appakkodal Village, Bhavani Taluk, Erode District.

4. Learned counsel for the petitioner on instructions would submit that he is satisfied with the statement made by the learned counsel for the respondents 3 & 4.

5. After recording the rival submissions, this writ petition is disposed of. No costs.
