PRAYER : Petition filed under Article 226 of the Constitution of India praying to issue a writ of Certiorarified Mandamus calling for the records relating to the order of the 2nd Respondent in Na.Ka.No.1737/A4/07 dated 10.03.2011 and quash the same and consequently direct the Respondents to regularize the service of the petitioner as Games Marker at 5th Respondent School and to pay time scale of pay from 01.09.1999 as per G.O.Ms.No.527, dated 30.12.1997 and absorb him as Office Assistant as per Government Letter No.235, dated 23.11.2006 and also as per letter of 1st Respondent in Na.Ka.No.07348-01-R8, dated 24.01.2007.

The Petitioner challenges an order dated 10.03.2011 of the second Respondent herein and consequently seeks regularization of his services as Games Marker in the fifth Respondent School.
