Prayer in W.P.No.20230 of 2013: This Writ Petition filed under Article 226 of the Constitution of India to issue a Writ of Certiorarified Mandamus, call for all the connected records in the impugned orders of granting further extension from 01.06.2013 F.N. to 31.05.2014 A.N. vide G.O.(Ms)No.86 PW (A2)D dated 31.05.2013 beyond 31.05.2013 A.N.(for a second term) to the Engineer, R.Gopalakrishnan, Engineer in-chief (Buildings), who is also permitted to hold another 2 posts - The Chief Engineer (Buildings), Chennai Region and the Chief Engineer, (Genl.), PWD, Chennai - 5, and to quash; consequently to appoint a person clean for these posts, separately.

Prayer in W.P.No.20365 of 2013: This Writ Petition filed under Article 226 of the Constitution of India to issue a Writ of Certiorari, call for the records related to the G.O.Ms.No.86 PW(A2) dated 31.05.2013 passed by the 4th respondent and to quash the same as illegal and unsustainable under law.
