2. When the matter was called on 21.04.2021, the matter was adjourned to 09.06.2021. Then, while the matter was posted on 16.06.2021, at the request of the Government Advocate, the case was posted on 08.07.2021 for filing of counter. On 08.07.2021, the matter was directed to post on 20.07.2021 while the learned counsel for the petitioners reported as no instructions from the parties and the learned Government Advocate filed counter. When the matter came up for hearing on 20.07.2021, there was no representation for the petitioners.
