Today, when this matter was taken up for consideration, the learned counsel for the petitioner, on instructions, submitted that subsequent to filing of this Writ Petition, the third respondent, against whom, disciplinary proceedings was sought to be initiated, retired from service and hence the relief sought for herein has become infructuous and therefore nothing survives for adjudication in this writ petition.
