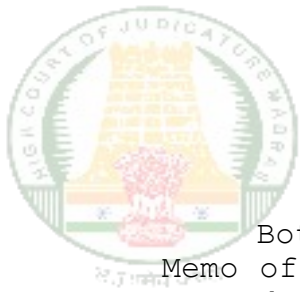

Writ Petition is ordered accordingly.
