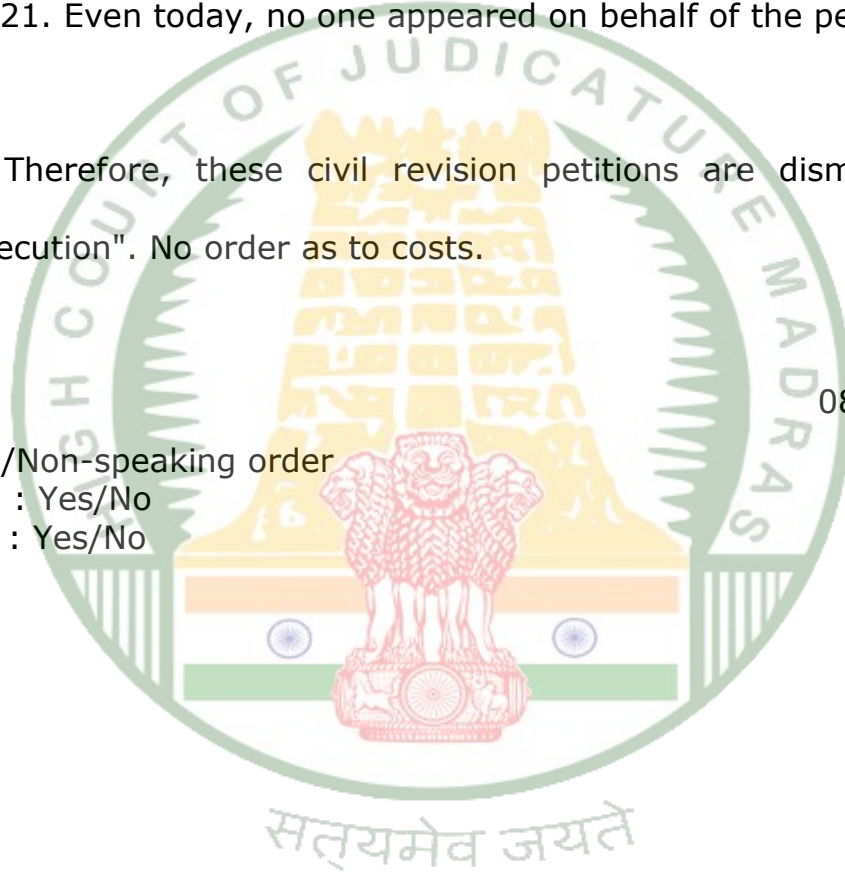
2. When the matter was listed on many occasions, the learned
