PETITION FOR ANTICIPATORY BAIL Under Sec. 438 Cr.P.C.

ORDER : The Court Made the following order :-

The petitioner, who apprehends arrest at the hands of the respondent police for the offences punishable under Sections 341, 326, 506(ii) r/w 34 of IPC in C.C.No.4671 of 2013, seeks anticipatory bail.

2.The learned Additional Public Prosecutor appearing for the respondent Police would submit that Non Bailable Warrant has been issued against the petitioner on 02.03.2015 and the same is pending.

3.Considering the fact that NBW is pending against the petitioner, this Court is not inclined to grant anticipatory bail to the petitioner. However, the petitioner is directed to appear before the learned XVI Metropolitan Magistrate, George Town, Chennai, within a period of two weeks from the date of receipt of a copy of this order and to file a petition under Section 70(ii) of Cr.P.C., to recall NBW already issued against him. On filing of such petition, the concerned Magistrate, is directed to consider the same on merits and pass order on the same day.

4.This Criminal Original Petition is, accordingly, disposed of.
