Since the petitioner has not appeared before the respondent and not cooperating with the investigation, the respondent police is not in a position to proceed with investigation.

2. In such circumstances, the petitioner is directed to appear before the respondent police daily for a period of two weeks from 01.04.2021 and thereafter as and when required.

3. This petition is ordered accordingly.
