2.Recording the submission made by the learned counsel appearing for the petitioner, this Civil Revision Petition is dismissed as infructuous.

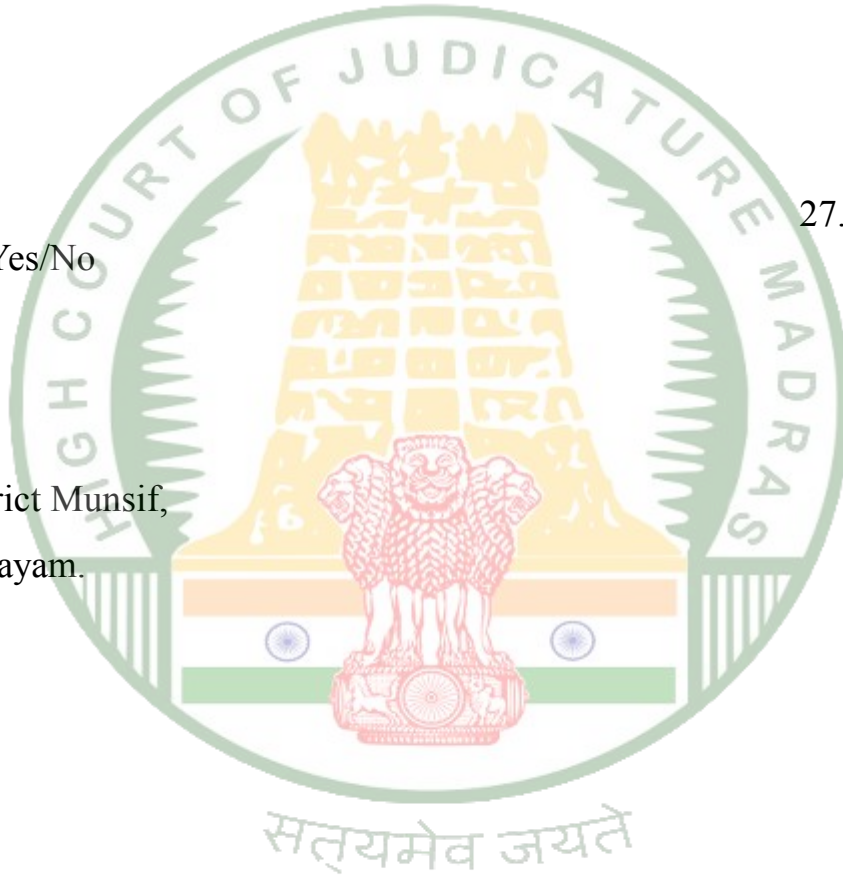

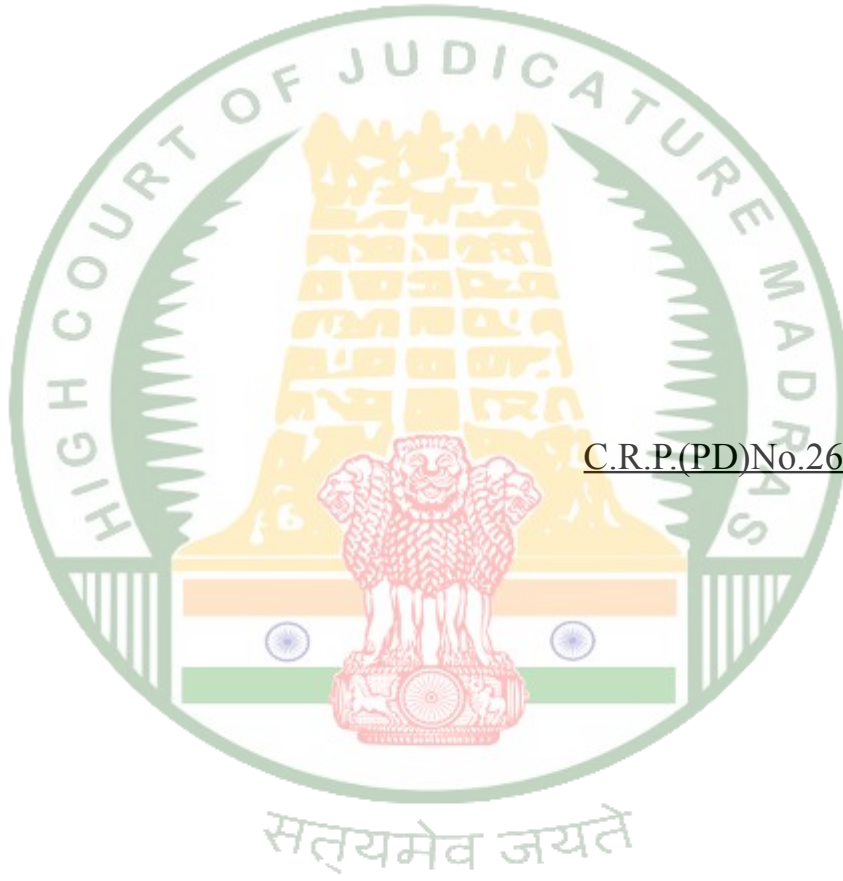
