The petitioner has filed the present writ petition seeking for issuance of a writ of Mandamus, directing the respondents to sanction the personal pay of Rs.750/- to the petitioner from 01.12.2006 and consequentially, revise the scale of pay of the petitioner in the cadre of B.T.Assistant, by considering the representation of the petitioner dated 05.02.2021.
3. This Court heard the submissions of the learned counsel on either side and perused the materials available on record.
4. The writ petition is squarely covered by the earlier orders passed by the Madurai Bench of this Court in W.P(MD) No.19240 of 2014, dated 02.01.2018 and W.P.(MD)No.16801 of 2015, dated 11.02.2020. Since the issue involved in this writ petition is covered by the earlier orders of this Court, this writ petition stands allowed and the respondents are directed to sanction the personal pay of Rs.750/- to the petitioner from 01.12.2006 and consequentially, revise the scale of pay of the petitioner in the cadre of B.T.Assistant, by considering the representation of the petitioner dated 05.02.2021, within 8 weeks from the date of receipt of a copy of the order.
5. With the above directions, this writ petition stands disposed of. No costs.
