handover the Original Bank Guarantee to the 2nd Respondent Counsel on or before 07.04.2021. It is submitted that due to the State Legislative Assembly Elections, the Original Bank guarantee was handed over to the 2nd Respondent Counsel on 08.04.2021. This proof of the same is enclosed herewith. Therefore, it is humbly prayed that this Hon'ble Court may be pleased to accept the memo of compliance and thus render justice."

3. In view of the same, no further orders are necessary to be passed in these applications and hence, the same stand closed.
