Considering the limited prayer, without expressing any opinion on merits, a direction is given to the second respondent to forward the proposal to the fourth respondent to consider the representation of the petitioner dated 07.08.2020, on merits and in accordance with law and pass appropriate orders within a period of four weeks from the date of receipt of a copy of this order.

5. The writ petition is disposed of accordingly. No costs.
