that he will secure an allotment of house in the Tamil Nadu Housing Board.

However, the learned counsel appearing on behalf of the first respondent states that they are noway connected with the affairs of the fourth respondent and the fourth respondent is not an employee of the Tamil Nadu Housing Board. This being the factum. The petitioner is at liberty to initiate appropriate action against the fourth respondent by approaching the competent authorities.

4. With this liberty, the Writ Petition stands disposed of. No costs. Consequently, connected miscellaneous petition is closed.
